Council for the City of Crittenden met for its regular meeting with the following present:

Mayor James C Livingood; Councilperson Clara Brown; Councilperson Roger Humphrey; Councilperson Brian Barkley; Councilperson Donna Duley. Guest: Shayne Ling with Precision Concrete Cutting. Mayor Livingood called the meeting to order at 7:00 p.m.

Agenda was approved.

Motion by Councilperson Roger Humphrey, seconded by Councilperson Brian Barkley to approve the minutes of the regular meeting, May 1, 2018 and the minutes from the special meetings on May 21st and May 22nd 2018. Motion carried, all yes.

Motion by Councilperson Brian Barkley, seconded by Councilperson Donna Duley to approve the treasurer's reports for the month of May 2018 as read. Motion carried, all yes.

Motion by Councilperson Clara Brown, second by Councilperson Brian Barkley to approve Ordinance No. 260-2018 an ordinance relating to the annual budget for fiscal year 2018-2019. Motion by Councilperson Brian Barkley, seconded by Councilperson Donna Duley to approve Ordinance No. 261-2018 an ordinance relating to an amendment of the zoning ordinance of the City of Crittenden. Motion carried, all yes.

Shayne Lingg with Precision Concrete Cutting presented the Mayor and Council with a presentation on how to repair sidewalk trip hazards.

Motion by Councilperson Clara Brown, seconded by Councilperson Donna Duley to select Option A presented by Precision Concrete Cutting in the amount of \$19,421.44 to repair the sidewalks. Motion by Councilperson Donna Duley, seconded by Councilperson Clara Brown for the Mayor to sign the Contract with the Crittenden Volunteer Fire Department in the amount of \$65,000.00 for the fiscal year 2018-2019. The vote was: Councilperson Clara Brown - yes; Councilperson
